



Track Rules

- This general rule section applies to each and every person as well as track personnel. You are expected to know the rules. A racing program is considered complete after all heat races are complete. There will be no rainchecks issued for general admission nor pit admission. If all heat races are not run, keep your pit pass or get a general admission ticket stub at the ticket booth. You may use the armband or stub to get in free at one of the regular Saturday Night shows in the next 2 weeks.

1. All decisions, judgement calls, or interpretations or the rules by track personnel and management is final.
2. Any competitor or spectator by entry onto 67 Speedway grounds, agrees to abide by the rules of the speedway and acknowledges that the failure to comply with them will result in their removal from 67 Speedway.
3. 67 Speedway reserves the right to refuse admittance to the speedway, sale of a ticket to an event held at the speedway or remove any individual from the speedway for any reason.
4. No driver, car owner, mechanic, or spectator shall hold claim for damages, expenses, or the like against 67 Speedway, speedway management, speedway personnel, or speedway sponsors.
5. All drivers, car owner, mechanic, and spectators assume full responsibility for any and all injuries sustained, including death and or property damage, any time that they are on the racetrack premises or in route to or from the 67 Speedway.
6. We always expect courteous conduct from all participants. Every participant is expected to conduct themselves in a manner which will promote a positive image for the track and motorsports as a whole. Profanity, obscene, or improper behavior in front of race fans, officials, or management will NOT be tolerated.
7. If at any time your dress, actions, or conduct are not in the best interest of the track, its fans, competitors, or the sport of auto racing, you must leave the grounds and suspension, or disbarment may result.
8. The track is private property, through your admission ticket you have been given authority and the right to be on this property in conjunction with the racing activities. However, the management of the track reserves the right to revoke and cancel this right at any time it is determined that your presence or conduct is detrimental to the track, the sport of auto racing, your fellow competitors, the fans or the management of the track.

9. Drivers are responsible for their crews, family members, and anyone known to be associated in any way with their car.
10. Any person entering pit area must sign a release and purchase a pit pass before entering the pits. Releases must be signed by the individual entering the pit area, except for minors, who must be accompanied by a guardian or parent. All persons in the pit area must always have their pit pass in their possession and visible. Pit passes must be worn on the purchaser's arm or belt loop. NO EXCEPTIONS!
11. Any person who encourages or takes part in adverse demonstrations or fighting on the track or surrounding premises before, during, or after a racing event shall be subject to arrest, fine, immediate suspension and/or loss of prize money and all championship points that have been earned. Track insurance EXCLUDES bodily injury or property damage as a result of fighting. This also applies to any person going to another person's pit area using profanity, obscene gestures, provoking and/or starting a fight.
12. Any person who shall commit assault or threaten to do bodily harm to any speedway official or any other person under their orders, shall be barred from competition at the track and/or subject to prosecution.
13. Any unsportsmanlike conduct at the raceway will not be tolerated and disciplinary action will be taken up to and including permanent suspension and arrest of all parties involved.
14. The drinking of alcoholic beverages or use of controlled substances by drivers will not be allowed. In the event a violation involving a controlled substance is discovered, the proper legal authorities will be notified. 2021 General Rules
15. The display or use of any type of weapon at any time will result in the suspension of all parties involved and the arrest of all parties involved.
16. Any disagreement over technical questions or decisions will be resolved by the officials and management of the track. When their decision is rendered it is final and binding and no further discussion will take place.
17. Management and officials will determine all finishing positions and their decision is final.
18. It is suggested that someone of your pit crew stay with your car at all times while it is in the pit area.
19. All track rules will be interpreted as track management interprets them. In addition, track management reserves the right to tech any car or any part of a car at any time.
20. No car or any motorized vehicle is allowed on the track after the last feature race without track management's permission. The car driver and/or owner of any car or motorized vehicle allowed on the track that wrecks or quits is responsible for getting their vehicle off the track.
21. Track premises shall be vacated within 1 hour after the last feature race. NO EXCEPTIONS!
22. No glass containers or bottles of any kind are permitted on the grounds of 67 Speedway.
23. Any one defaming or insulting 67 Speedway, the sport of auto racing, any other track, track officials, or drivers can be suspended from 67 Speedway indefinitely. You are encouraged to respectfully talk with the 67 Speedway officials about the situation you are concerned about. Any vague or direct threats to drivers, track personnel, or fans through social media, forums, or any other communication channel will result in you not being admitted to the speedway. You are entitled to your opinion and free speech, just as the speedway is entitled to not allow you admittance onto the property and/or the ability to compete in a racing event. Spoken or written words are done through actions, so please take a breath and think before you speak or post.
